The Government of the Islamic Republic of Afghanistan has received financing from the European Union (EU) and the Asian Development Bank (ADB) towards the cost of the Panj-Amu River Basin Sector Project (P-ARBP). part of this grant will be used for Payment under the contract named above. Bidding is open to Bidders from eligible source countries of the ADB.
2. The National Procurement Authority (NPA) on behalf of National Water Affairs Regulation Authority (NWARA) ("the Employer") invites sealed bids from eligible Bidders for the [Rehabilitation and Construction of Subprojects \(Yatim Tapa and Dashtqala Irrigation Sub-Project in Takhar\)](#)
3. National competitive bidding (NCB) will be conducted in accordance with the ADB's [Single Stage – Single Envelope](#) bidding procedure and is open to all Bidders from eligible source countries as described in the Bidding Document.
4. Only eligible Bidders with the following key qualifications (mentioned in Section 6) should participate in this bidding:

Financial Qualifications

No.	Item	Criteria Requirement
1	Pending Litigation and Arbitration	All pending litigation and arbitration, if any, shall be treated as resolved against the Bidder and so shall in total not represent more than fifty (50) percent of the Bidder's net worth calculated as the difference between total assets and total liabilities should be positive.
2	Historical Financial Performance	Bidder's Financial Position should be positive for the last 3 years
3	Average Annual Construction Turnover	Minimum average annual construction turnover of USD 4.09 million calculated as total certified payments received for contracts in progress or completed, within the last Five (5) years.

4	Financial Resources	An amount of USD 683,000.00 should be available for the project in excess of Total Financial Requirements for Current Contract Commitments
	For Joint Ventures:	(1) One partner must demonstrate that its financial resources defined in FIN-3, less its financial obligations for its own current contract commitments defined in FIN-4, meet or exceed its required share of USD 273,200.00 from the total requirement for the Subject Contract. AND
		(2) Each partner must demonstrate that its financial resources defined in FIN-3, less its financial obligations for its own current contract commitments defined in FIN-4, meet or exceed its required share of USD 170,750.00 the total requirement for the Subject Contract. AND
	(3) The joint venture must demonstrate that the combined financial resources of all partners defined in FIN-3, less all the partners' total financial obligations for the current contract commitments defined in FIN-4, meet or exceed the total requirement for the Subject Contract of USD 683,000.00	

Note: if a bidder participated in more than one bid, the bidder must meet the cumulative financial requirement determined for each bid.

1	Contracts of Similar Size and Nature	Participation in at least one contract that has been successfully or substantially completed within the last ten years counting backward from the date of bid submission and that is similar to the proposed works, where the value of the Bidder's participation exceeds USD 2.86 million . The similarity of the Bidder's participation shall be based on the physical size, nature of works, complexity, methods, technology or other characteristics. Bidders shall submit copies of contracts/ completion certificates in case of completed contracts or substantial completion certificates where works have been substantially completed. Such documents should be on the employer's letterhead clearly indicating the name of the employer, name of project, brief scope, contract amount, and contact details of employer. In case the documents are not available in English, an English notarized version duly certified by a translator should be provided.
